



TWENTY SIXTH ANNUAL BELLA VISTA BRONCO TRACK AND FIELD INVITATIONAL

The 2010 Bella Vista Bronco Track and Field Invitational will be held on Saturday, April 10. The meet will be held at **Bella Vista High School** site of the 2010 Sac Joaquin Section Division 2 Trials and Finals. In order to ensure that the fields for each event are reasonably sized, the number of schools entering full teams will be limited to approximately twenty (20), determined on a "first come-first served" basis.

The standard set of metric track and field events will be held for the three (3) athlete classifications – freshmen/sophomore (frosh/soph) boys, varsity girls, and varsity boys. Each school will be allowed three (3) entries in all field events and individual track events except the discus and long jump, which will be allowed two (2) entries, and the 1600 M, and 3200 M which will be allowed five (5) entries. The 400 meter (M), 1600 M relays will get one (1) entry per school. Morning heats will begin at 9:00 am in the 100 M and 200 M and the 110 M Intermediate (36") hurdles (IH) (frosh/soph boys), 100 M Hurdles (varsity girls), and 110 M HH (varsity boys) to determine those athletes qualifying for the finals. All other track events will be run (as necessary) in "slow" and "fast" heats. Finals will begin approximately fifteen (15) to thirty (30) minutes after the last morning heat – usually about noon. All races and/or heats will be electronically timed.

Distinctive medals will be awarded to the top six (6) finishers in both track and field events. In multiple heat finals the medals will be awarded based on time. A plaque will be awarded to any athlete that breaks a meet record. Team scoring will be determined for each classification with awards presented to the top two (2) schools in each classification.

Entry fees for the meet will be \$200.00 per school (\$75.00 per classification - \$150 for a school competing in two classifications and \$200.00 for a school competing in all three [3] classifications).

REMEMBER – The number of schools entering full teams will be limited to approximately twenty (20), determined on a "first come-first served" basis.
